### Mainstream Fund Services Announces Senior Appointments

Both Angela and Barbara will report to Mainstream’s Group CEO and co-founder, Martin Smith.

**Martin Smith**, Group CEO of Mainstream, commented “Both Barbara and Angela have been a key part of the success of our Irish and Cayman operations and we are pleased to be able to promote talented people from within our organisation into senior leadership roles.
